

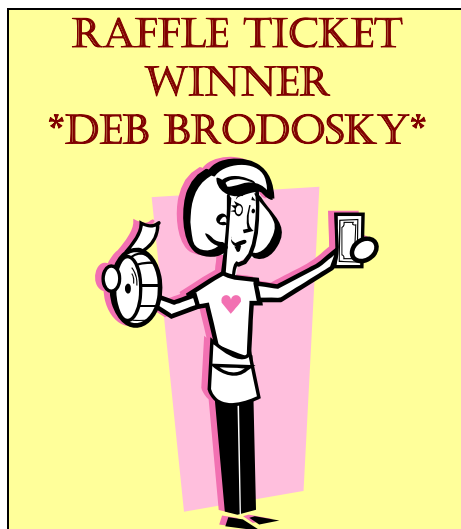
# CCPA, Inc. Newsletter
