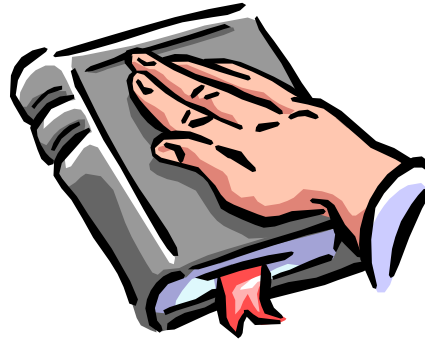
Up & Coming – Social Hour
