The Christmas party is on December 20, 2008. Please RSVP by December 1st. It will be held at Highland Country Club. There will be a gift exchange at the Christmas party.

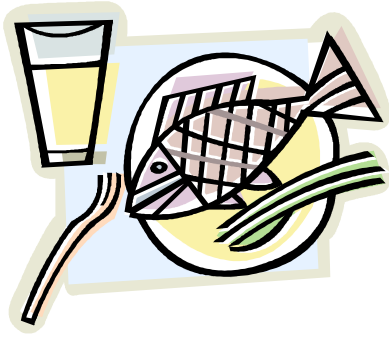
The next evening meeting will be February 12, 2009 with H. Terry Hutchens as the guest speaker.
